Education and Training: I was trained in hypnotism or hypnotherapy at The New England School of Hypnotherapy in Northport Maine. This school is state licensed. I am a Certified Member of the National Guild of Hypnotists and I do annual continuing education to maintain my training at a high level.

Hypnotism is a self-regulating profession and its practitioners are not licensed by state governments. I am neither a physician nor a licensed health care provider and may not provide a medical diagnosis nor recommend discontinuance of medically prescribed treatments. If a client desires a diagnosis or any other type of treatment from a different practitioner, the client may seek such services at any time. In the event my services are terminated by a client, the client has a right to coordinated transfer of services to another practitioner. A client has a right to refuse hypnotism services at any time. A client has a right to be free of physical, verbal or sexual abuse. A client has a right to know the expected duration of session, and may assert any right without retaliation.

Redress: I am a certified member of the National Guild of Hypnotists, and practice in accordance with its Code of Ethics and Standards. If you ever have a complaint about my services or behavior that I cannot resolve for you, you personally may contact the National Guild of Hypnotists at P.O. Box 308 Merrimack, NH 03054-0308, (603) 429-9438, to seek redress. Other services than my own may be available to you in the community. You may locate such providers in the telephone book.

Fees: The fee for Hypnosis is \$150.00 for the initial visit and \$100.00 per one-hour session thereafter. I must be paid in full at time of services. Cash and Checks accepted.

Confidentiality: I will not release any information to anyone without a written authorization from you, except as provided for by law. You have a right to be allowed access to my written record about you.

Insurance: I suggest you think of my services as something that you will pay for personally. That will both protect your privacy and help you value the work you are doing more. In general, insurance companies do not like to cover hypnotic services and I caution you not to expect them to do so.

My Approach: Hypnosis will help you access your own inner power to achieve the "You" you want to be. Everyone has deep within themselves in their subconscious mind all the wisdom and personal knowledge needed to attain measurable results in eliminating unwanted behaviors, releasing negative feelings, and possessing self love.
